#### Course provisions

Fenton High School Driver Education will provide a minimum of 6 hours classroom instruction by a certified instructor. Classroom instruction shall not exceed 2 hours a day.

#### Required language

**Notice: this provider is required to be licensed by the secretary of state. If you have a complaint which you cannot first settle with this provider, write: Michigan Dept. of State, Driver Programs Division, Lansing, MI 48918. Completion of driver education instruction does not guarantee qualification for a driver license.**

For a student to participate in segment 2, verification must be received that the student has completed a minimum of 30 hours of driving, including 2 hours at night, with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 consecutive months.

***Driving log should be brought to first day of class.***

#### Terms

1. The parent or guardian agrees to pay the amount of **\$40** which needs to be paid in full by January 25<sup>th</sup> or February 23<sup>rd</sup>.
2. Requirements to pass the course: a) 100% attendance and attention  
b) completion of all assignments, in and out of class  
b) passing score of at least 70% on state test
